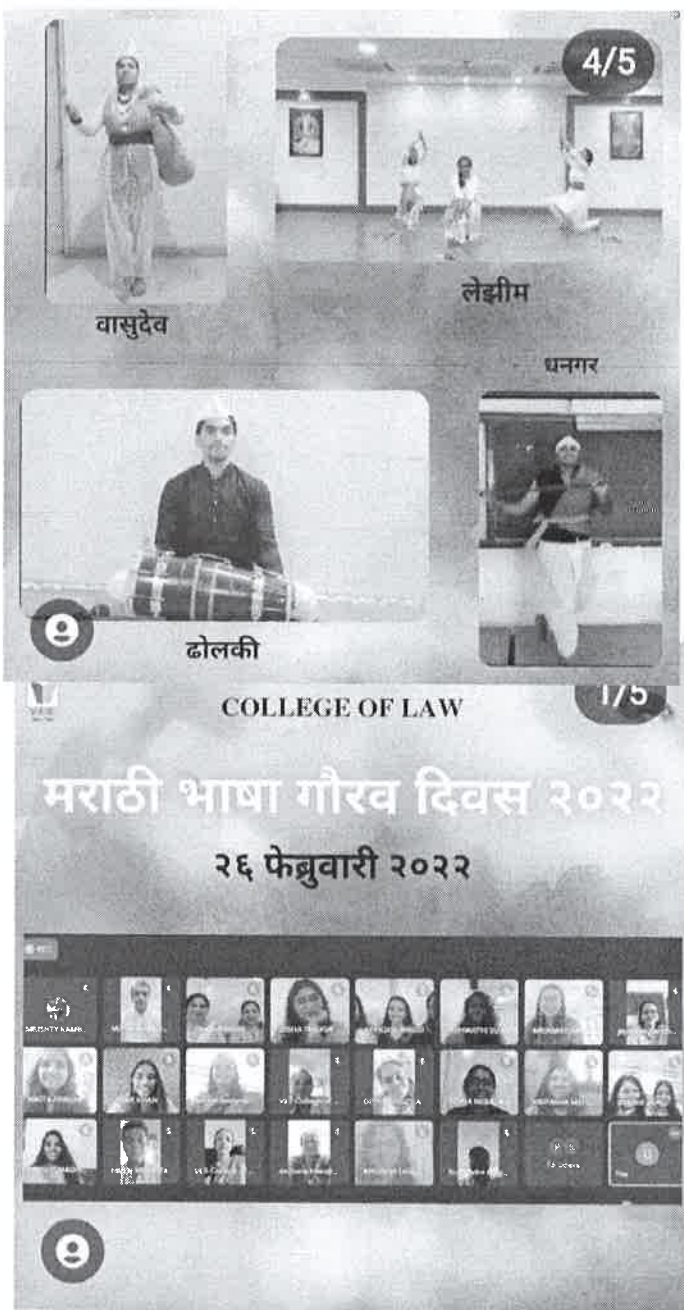

V.E.S College of Law had organized Intra College Debate Competition on 25th March 2021 to increase the soft skills in the student.

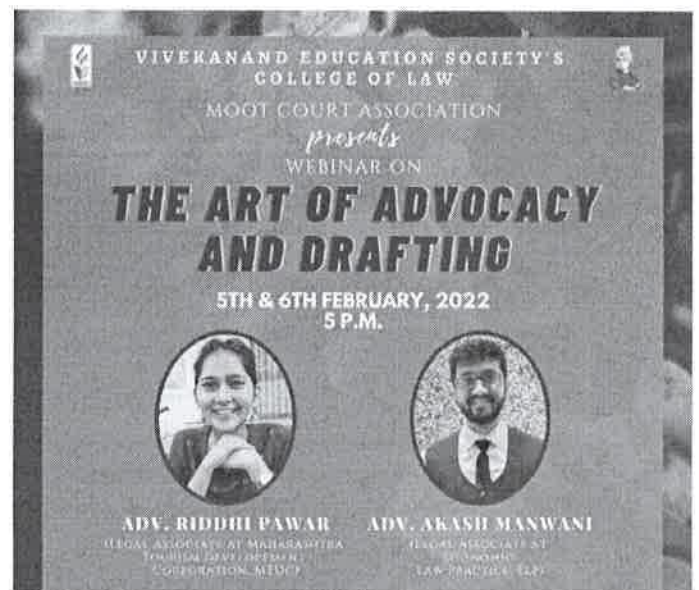


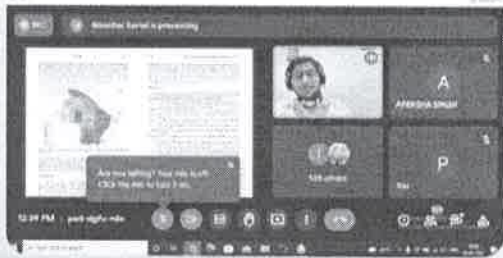

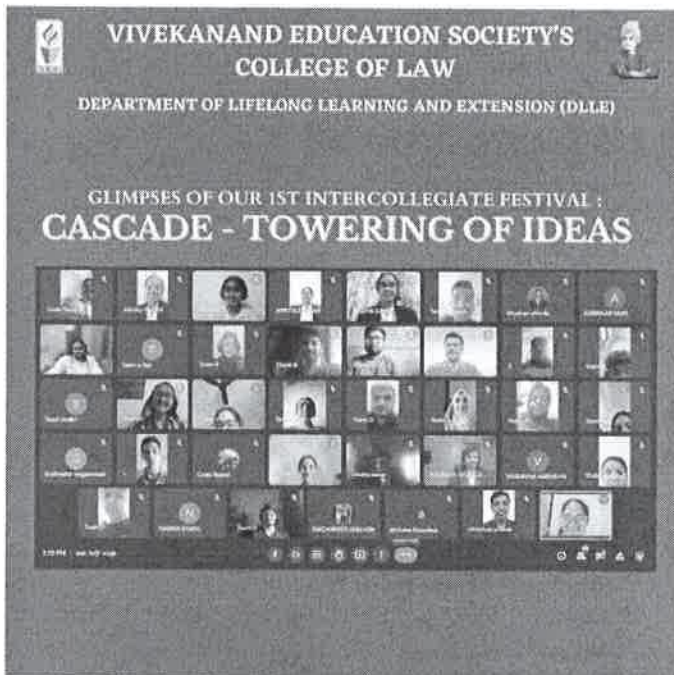
