This year also we have planned to visit the National Green Tribunal. The approximate number of students (87) and Faculty and Administrative Staff members (8) is around Ninety five (95).

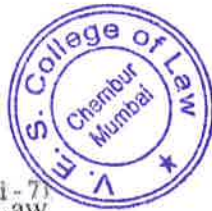
