### 4.2.1 - Library is automated using Integrated Library Management System (ILMS)

The VES College of Law Library utilizes the KOHA Open-Source Integrated Library Management Software (ILMS) for its daily library operations. This software enables the library to maintain international standards in managing its resources efficiently.

**Cloud-Based Solution:** Koha is hosted on a cloud server, which ensures that the library's operations run smoothly without interruption. The cloud-based system ensures secure data storage and remote access to the system.

**Automation History:** The VES College of Law Library has been automated since 2021-22, initially using the E-granthalay software. In 2022-23, the management decided to switch to Koha to support centralised utilization, providing more flexibility, cost-efficiency, and alignment with international standards.

Below is a detailed, categorized overview of how Koha supports the library's functions:

#### **Library Modules and Functions:**

Koha covers all major aspects of library management and operations, and it is used for the following primary modules:

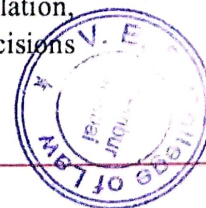
- **Catalogue for Bibliographic Database:** The library maintains an up-to-date, structured bibliographic database using Koha. This includes detailed records of books and periodicals.
- **Web OPAC (Online Public Access Catalog):** The Web OPAC allows users (students, faculty, and staff) to access the library's Catalog from anywhere, without needing login credentials.
- **User Database:** Koha maintains detailed user profiles, including students, faculty, and staff, which are necessary for tracking library access and activities.
- **Circulation Module:** The circulation module automates the borrowing, returning, and renewal processes, including fine management for overdue items. It also allows the tracking of books and resources, ensuring efficient circulation management.
- **Reports:** Koha supports the generation of various reports related to circulation, acquisitions, fines, and more. These reports help the library make informed decisions about resource management.
