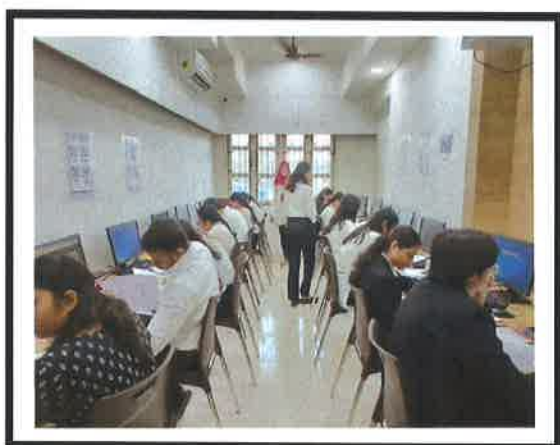

An hour prior to the start of the competition, all the teams were assigned the party they will be representing in the preliminary round (requesting or responding). A member from each



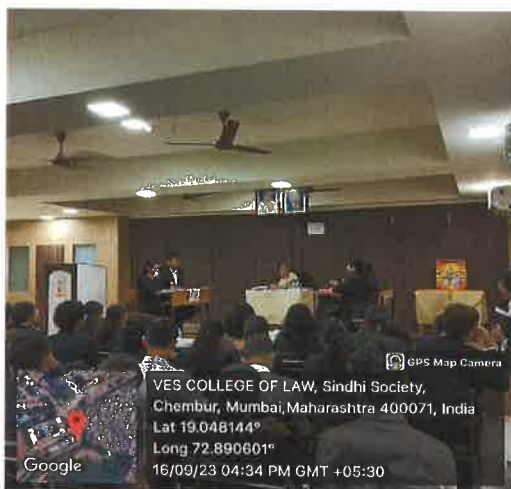

Rules and Regulations:

I. Registration:

II. Topics and Scheduling:

Topics, primarily based on legal principles, current legal events, landmark judgments, or pressing legal issues, will be assigned through a draw of lots 30 minutes before the allocated presentation slot.

III. Preparation:

- Participants have 30 minutes for preparation.
- Reference materials can be from the Library, the Internet, or personal collections.
- After the 30-minute preparation time, participants must be seated in the designated place.
- No mobile phones or books would be allowed in the designated place.

IV. Conduct of Speech:

- Duration: 3 minutes for each participant.
- Speech Structure:
 - **Introduction:** Offer a context to the topic.
 - **Body:** Discuss the topic, provide arguments, counter arguments, and cite relevant case laws.
 - **Conclusion:** Summarise the primary points.
- **Prohibited Content:** Avoid derogatory, discriminatory, or inappropriate comments.
- **Conduct and Behavior:** Maintain respect and discipline. Indiscipline can lead to penalties or disqualification.
- **Q&A Session:** Judges may ask questions post-presentation to test clarity and knowledge.

V. Judging Criteria:

Content: accuracy, analysis depth, originality - 10 marks.

Organisation of thought: 10 marks

Delivery: voice clarity, fluency, pronunciation, modulation - 10 marks.

Presentation: body language, eye contact, gestures - 10 marks.

Response to question: 10 marks

NOTE: Failure to appear at the designated place post-preparation will result in disqualification.



The objective is to imbibe mooting and debating skills in law students; cause them to become familiar with the formal procedure of the courts; and set them up on their journey to

1. Short Title:

This competition shall be referred to as the "7th Edition Intra Collegiate Moot Court Competition, 2023" held by the Vivekanand Education Society's College of Law.

2. Definitions:

In the context herein:

- i. "**Appellant**" includes Appellant, Plaintiff, Petitioner, Complainant, Prosecution, Informant, etc.
- ii. "**Bench**" pertains to the individuals invited to judge the oral rounds, either individually or as a panel.
- iii. "**Clarifications**" refer to explanations provided by the Host University regarding queries from participating teams within the stipulated deadline.
- iv. "**Competition**" denotes the Intra Moot Court Competition.
- v. "**Moot Proposition**" signifies the problem released by the Organizers on the specified date in Rule II (2), including subsequent clarifications.
- vi. "**Oral Score**" denotes the scores awarded by judges to a particular speaker from a participating team during oral assessments.

xii. "**Written Submissions**" signifies the memorandum of written submissions (memorials) submitted by any participating team according to the Competition rules.

3. Date and Venue of the Competition:

The Intra Moot Court Competition will take place on 28th Day of October, 2023 at the Vivekanand Education Society's College of Law. The mode of the Competition will be offline.

4. Team Eligibility and Composition:

Participation is limited to bona fide law students pursuing the

participating team must consist of three members, with two designated as 'Mooter' and one as 'Researcher.'

5. Registration Procedure:

Registration for the moot will commence on 9th October, 2023 at 1:00 PM near the Office Wing Stilt Area. A total of 16 slots are available on a first-come-first-served basis.

Teams backing out will be barred from the further competitions conducted by the Moot Court Association.

6. Written Submissions:

Written Submissions should adhere to specific guidelines regarding formatting and should contain inter alia the following.

6.1 Written Submissions Structure:

The Written Submissions must contain the following contents:

- Cover Page – The cover page shall contain the case title, side of the written submission, year of Competition, name of the forum, and team Code in the top right corner;

- Table of Contents

6.2 Guidelines for Formatting:

- Font, size, and line spacing: The text font should be Times New Roman, size 12, and must be in 1.5 line spacing.
- Footnotes: The footnotes must be in font Times New Roman, size 10, and singly spaced. The Bluebook: A Uniform System of Citation (20th Edition) should be followed in the written submission throughout.
- Header and Footer: The font used for the header/footer, if any, shall be Times New Roman, size 10, and 1 spacing.
- Page Limit: The maximum page limit on the Written Submissions is 25 pages. No annexures, photographs, exhibits, etc. should be added to the written submission.
- Binding of Written Submission: Since the college follows the principles of SDG, it encourages eco-friendly practices, hence, it is recommended that the teams bind their written submission with



- eco-friendly method of binding.

6.3 Memorial Submission:

- All memorials submitted for all purposes of the Competition shall firmly comply with the rules of the Competition. Each participating team must prepare two written submissions, one for each Petitioner/Applicant(s) as well as Respondent(s) side.
- Petitioner/Applicant(s) memorials are required to have a Blue Cover and Respondent(s) memorials are required to have Red Cover.
- Teams have to prepare Written Submissions for both the sides in the Competition. Memorial submissions are to be made before 11:59:59 PM on 25th of October, 2023 in the format of soft copies of memorials shall be submitted in either .pdf or .doc/.docx via google link that will be notified accordingly and 4 hard copies shall be submitted by 2:00:00 PM on 26th of October, 2023.

Non-compliance will result in penalties and shall attract deduction of $\frac{1}{2}$ mark on each contravention. Late submission than the given deadline shall attract deduction of 1 mark each per hour. After 12 hours, the memorial shall not be considered for submission. 7. Oral Pleadings:

There will be a total of **4 rounds** of the Competition. The rounds will be Preliminary Round (Round 1 & 2), Semi Finals and Final Round.

● Preliminary Rounds

Each team will get a total of 15 minutes to present their case. This time will include rebuttal and sur-rebuttal time [if permitted by the judge(s)]. The time distribution per speaker is left at the discretion of the teams subject to a minimum of 6 minutes per speaker and no more than 8 minutes per speaker. Rebuttals can be allocated a time of a maximum of 2 minutes. In Preliminary Round 2 all the teams will switch their sides and argue.

The Draw of Lots for this round will be held in due course of time. Top 4 teams i.e. 1 team from each **COURT ROOMS** will qualify for the Semi -Final Rounds.

● Semi-Finals

Each team will get a total of 20 minutes to present their case. This time will include rebuttal and sur-rebuttal time [if permitted by the judge(s)]. The time distribution per speaker is left at the discretion of the teams subject to a minimum of 8 minutes per speaker and not more than 10 minutes per speaker. Rebuttals can be allocated a time of a maximum of 2 minutes.

REPORT

7th Intra-Collegiate Moot Court Competition, 2023

The 7th Intra-Collegiate Moot Court Competition was organised by the Moot Court Association of VES College of Law on the 28th of October, 2023. The main objective of this competition is to inculcate moot culture amongst the students and to prepare them for national and international level competitions. 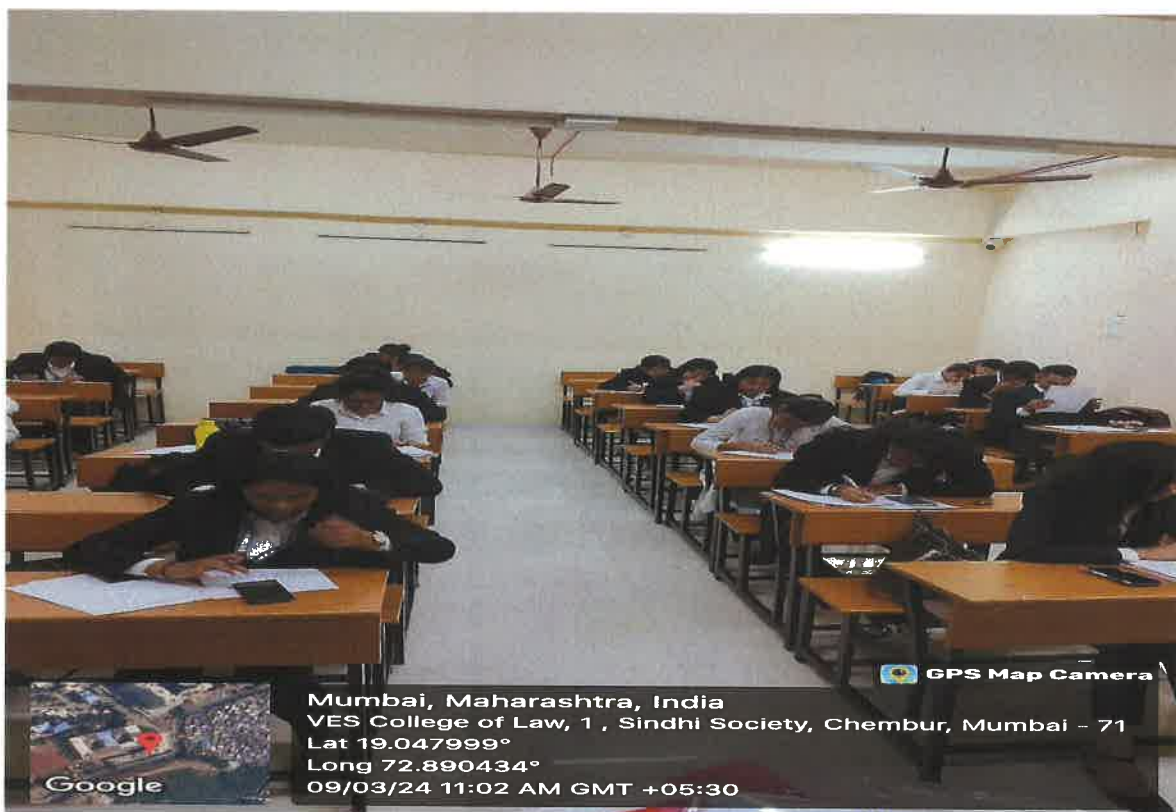

They are hereby informed that the recommendations made by the Ad-hoc Board of Studies in Law at its online meeting held on 27th May, 2022 vide item No. 2 (a) and subsequently passed by in the faculty of Inter-Disciplinary Studies and then by the Board of Deans at its meeting held on 5th July, 2022 vide item No.8.3 (A) have been accepted by the Academic Council at its meeting held on 11th July, 2022 vide item No. 3.3 (A) and subsequently approved by the Management Council at its meeting held on 28th July, 2022 vide item No. 8 and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 74(4) of the Maharashtra Public Universities Act, 2016 (Mah. Act No. VI of 2017) for the amendment of 5.3.1 of the manual annexed to the circular No. UG/107/2018-19 dated 24th August, 2018 which has been subsequently implemented from the academic year 2019-20 vide circular No. UG/19 of 2019-20 dated 20th May, 2019 be amended as follows:-

CBCS 60:40 introduced in 2019-20 should be replaced by CBCS 75:25. Passing minimum shall be 40% in both internal and external evaluation. The new 75:25 CBCS will commence to have force from 2022-2023. This will be applied to the first year students of LL.B 3yrs and LL.B 5yrs and progressively thereafter as the students proceed to higher class and new students get admitted. Consequential changes about the pattern and duration of external evaluation and norms on internal evaluation shall be made as per appendix from the academic year 2022-23. (The circular is available on the University's website www.mu.ac.in).

COURSE OBJECTIVES:

Overall, this course intends to comprehensively familiarize students with Administrative Law which is concerned with controlling the misuse of public power, by laying down general norms of administrative behaviour.

COURSE OUTLINE

COURSE OBJECTIVES:

Study of procedural law is enormously pertinent for law students. This course is designed to acquaint the students with the various stages through which a civil case passes through in the courts of law. The course also includes law of limitation. The course aims to assist the students to understand the practice and procedure in the conduct of suits in and out of the court. It will also analyse this consolidated code with the substantive laws with regard to the procedure to be followed by the civil courts and thereby help in facilitating justice. The course thus explains in detail the role of civil court and the procedures to be followed in the administration of civil justice.
