The lecture underscored the importance of integrity, diligence, and dedication in the legal profession and left students with a strong sense of responsibility to contribute meaningfully to the justice system.
























- Value of the subject matter specified in the Act



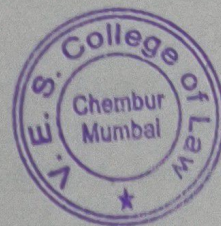


- Section 3 to 7 of the Act which states the Constitution of Commercial Courts
