### Seminar Report: **Voyage of Vigilance - Unveiling the Secrets of Road Safety**

Date: August 23, 2023

The workshop on " Voyage of Vigilance - Unveiling the Secrets of Road Safety" held on August 23, 2023, talked about the critical issue of road safety, presenting an in-depth analysis of current challenges, key contributing factors, and potential strategies to enhance road safety; the workshop was delivered by Deputy Regional Transport Officer Mr. Vinay Ahire who took on a fabulous start by explaining road safety being a global concern with significant social, economic, and health implications, despite numerous efforts road accidents continue to result in a high number of fatalities and injuries worldwide.

The workshop dived into the convolutions of road safety wherein Mr Ahire also said that road safety education should be included in school curricula to instil responsible road behaviour from a young age. The workshop embarked at the scheduled time that is 10:00 AM with an awe-inspiring response from the student community. The event was truly an eye opener for the audience. Mr. Ahire showed statistics of people dying in Maharashtra resulting in death, injury and accidents. Later on, an interesting concept of "Road Hypnosis" was explained Mr. Dattatraya Dhanawade Sir, during his speech audience listened to him meticulously.

Mr. Vinay Ahire our esteemed guest speaker of the day went on to diligently explain in depth about the reasons causing accidents due to motor vehicles. His passion for indulging into road safety and urging the same to the audience was extremely praiseworthy. He imparted good amount of knowledge on the working of each and every aspect of motor vehicles. He minutely explained how the friction happens between a 4 wheelers tyre and the road beneath which eventually leads to bursting of the tyres and how one must check wearability of tyres. Several videos were shown about grievous accidents happened due to drivers' negligence.

The event came close to an end when Priyanka Salve a fellow student beautifully recited a poetry on road safety in Marathi. Mr. Sushant Dhumale Sir performed a song in Marathi called "Ghaar Maajhe Vaat Pahat" which showcased importance of road safety. And here comes the highlight of the event where helmets were distributed to fellow students who had a valid two wheelers licence; students were extremely grateful and delighted to receive the same.
