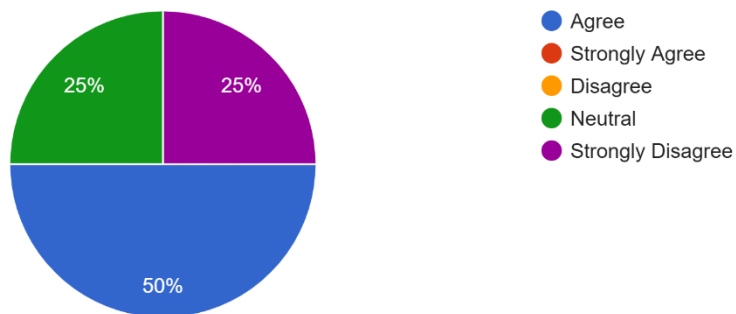

Curriculum Feedback (A.Y. 2023-24)

This feedback analysis report summarizes the evaluation of the curriculum for the academic year 2023-24, collected from three primary stakeholder groups: students, teachers, and alumni. The feedback aims to provide insights into the strengths and areas for improvement within the curriculum, helping guide future enhancements for both academic content and delivery.

A. Student Feedback

Curriculum Relevance and Content

Feedback:

A majority of students found the curriculum to be aligned with current industry trends (80% positive response). Some concerns were raised regarding the lack of updates in certain subjects. Students appreciated practical courses that incorporated case studies, workshops, and industry visits.

B. Teacher Feedback

Curriculum Design and Structure

Feedback:

Teachers were generally positive about the curriculum's clarity and logical flow. Many appreciated that it balanced theoretical and practical components. Some faculty members suggested that the curriculum could incorporate more interdepartmental learning opportunities and interdisciplinary projects.

Teachers recommended incorporating more real-world applications into courses and suggested fostering collaborations with industry experts to provide students with more exposure to practical work environments.

C. Alumni Feedback

Curriculum Relevance

Feedback:

Alumni generally felt that the curriculum had equipped them with a solid foundation for their professional careers. However, a few indicated that certain areas, such as entrepreneurship and modern technical skills, could be given more emphasis. Alumni working in global settings expressed the need for more content related to global perspectives and intercultural skills.

Alumni suggested the introduction of elective courses in newer fields such as artificial intelligence, digital marketing, and sustainability. Many alumni also felt that more emphasis should be placed on soft skills such as leadership, communication, and teamwork.

D. Employers Feedback

Feedback:

employers appreciate University's curriculum that offer a balanced curriculum that combines rigorous legal theory with practical skills training. They are looking for graduates who are not only knowledgeable about the law but are also equipped with the tools, skills, and mindset to navigate the increasingly complex and dynamic legal profession. Law Colleges that adapt their curricula to include hands-on experience, interdisciplinary knowledge, and modern legal technologies tend to receive the most positive feedback from employers.

Areas for Improvement

Curriculum Content: Incorporate more updates in fields such as technology, data science, and business management to keep pace with industry changes.

Recommendations for Future Curriculum Enhancement

- Collaborative and Interdisciplinary Learning: Introduce more interdisciplinary projects that involve students from different departments.
- Career Development Programs: Establish stronger connections with industries to provide internships, job placements, and networking opportunities.
- Continuous Feedback Mechanisms: Set up a system for ongoing feedback from all stakeholders throughout the academic year to ensure the curriculum stays relevant.
- Focus on Soft Skills: Integrate soft skills training in every course and provide more platforms for student leadership and collaboration.

The feedback from students, teachers, employers and alumni indicates that the curriculum for the academic year 2023-24 is largely effective but there are areas that require attention. By incorporating regular updates, increasing practical and interdisciplinary learning, and focusing on soft skills and career preparedness, the institution can continue to improve its academic offerings and better prepare students for future challenges.
