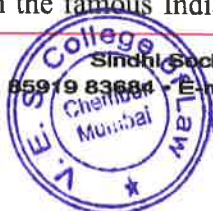
2. Song Presentations:

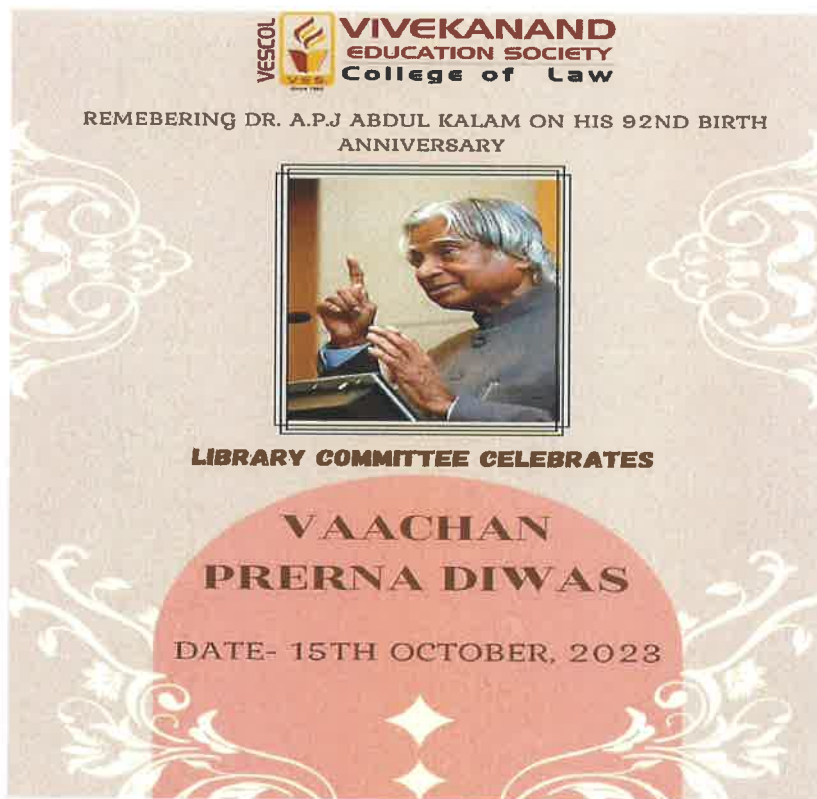

Date of Event: 26th November, 2023.

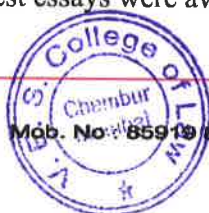
Organized By: Legal Aid Committee and DALSA (District Legal Services Authority)

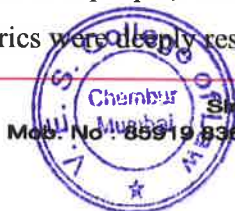
Key highlights of the event included:

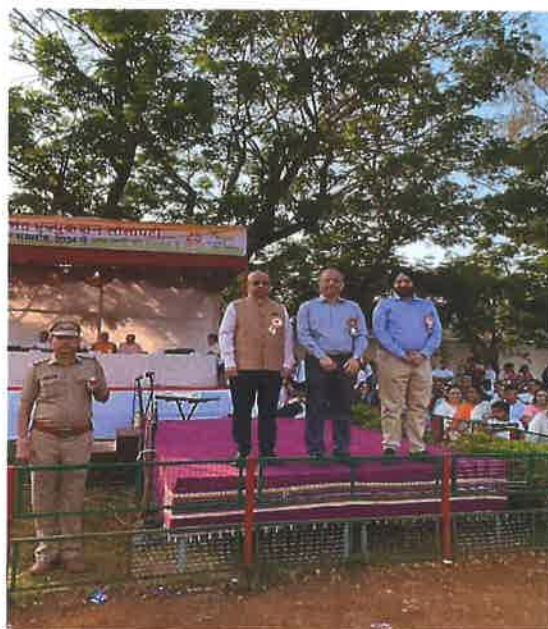
