

The 1st Freshers' Moot Court Competition at VES College of Law was successfully held on 2nd November 2023. Organized by the Moot Court Association, the event aimed to develop mooting and debating skills among law students, familiarize them with formal court procedures, and set them on their journey to seek justice. The problem focused on issues relating to Fundamental Rights with special emphasis on the Golden Triangle i.e. Art. 14, 19 and 21 of the Indian Constitution.

Registration for the competition took place offline on October 19, 2023, with an initial cap of 16 teams. However, the final participation included 15 teams due to one team backing out. Pre-competition meetings on October 19 and 23 provided participants with important information regarding the competition's rules and strategies. On October 31, a volunteers' meeting was held to allocate roles and provide additional event details. A draw of lots on November 1 determined the matchups and courtroom assignments for the competition.

The event was an excellent opportunity for fresh law students to familiarize themselves with formal courtroom procedures and hone their mooting skills.
