

## GUIDELINES FOR ANNUAL SCHOLARSHIPS FOR PG STUDENTS OF VIVEKANAND EDUCATION SOCIETY'S COLLEGE OF PHARMACY

The eligibility criteria for those availing scholarship from Universal Medicare Pvt. Ltd. (herein referred to as the "Company") are as under:

- I. The beneficiary should be a bonafide student of the College and be academically meritorious with more than or equal to the following aggregate percentage or CGPA:

Class	Examination	Aggregate % or Required CGPA
F.Y.M.Pharm	B. Pharm	60% or 7.0
S.Y.M.Pharm	M. Pharm Semester II	55% or 6.5

- II. The beneficiaries should be selected by a suitable College Committee and should be approved by the Principal.
- III. Age limit: 24 years ( F.Y.M.Pharm)  
25 years ( S.Y.M.Pharm)
- IV. Attendance should be 80% or more for F.Y.M.Pharm and 70% or more for S.Y.M.Pharm students respectively.

However, overall attendance in terms of regularity and promptness in research activities for S.Y.M.Pharm students will be judged from statement of recommendation issued by the research guide.

- V. If the prospective beneficiary is applying through merit cum means basis category, the income of the beneficiary's family should not exceed Rs.600,000/- (Rupees six lacs) per annum.

- VI. The candidate's parents and the candidate (if possible) must submit the following documents for scrutiny: PANCARD, Form 16, Income Tax Returns for 2 years, for those applying through merit cum means basis category.
- VII. No disciplinary action should have been taken against the candidate by the College.
- VIII. The beneficiary shall be eligible for this scholarship provided the total scholarship amount being taken from all sources does not exceed 80% of the applicable fees.
- IX. The Scholarship shall be called "**Universal Scholarship for Academic Excellence**".
- X. The Scholarship amount will be issued upon scrutiny of forms, verification of documents and personal interview of candidate and his/her parents, by the College Committee.
- XI. Payment of Scholarship amount will be made to the College, who will pay the candidate promptly post approval of the Grant, and this will be confirmed to the Company in writing.
- XII. A corpus of Rs.350,000/- (Rupees three lacs and fifty thousand only) per annum will be assigned to this Scholarship. Of this amount, 50% will be allocated to students from merit cum means category, while the balance will be allocated purely on merit.
- XIII. In case there is no student with less than Rs. 600,000/- (Rupees six lacs) annual income, the entire fund will be divided between students on merit basis purely.
- XIV. Of the abovementioned amount, it is proposed that Rs.200,000/- (Rupees two lacs only) is allocated towards F.Y.M.Pharm students with the balance Rs.150,000/- (Rupees one lac and fifty thousand only) being assigned to deserving S.Y.M.Pharm students.

- XVII. Certificates will be awarded to the beneficiaries upon completion of their projects.
