In the event of violation, the Council shall initiate penal action as per regulations and the extended EoA shall be withdrawn and the institution need to remit the TER charges only for EOA as per the Approval Process Handbook for the subsequent years also. The above mentioned approval is subject to the condition that **VIVEKANAND EDUCATION SOCIETY'S POLYTECHNIC** shall follow and adhere to the undertaking / affidavit given by the institution along with the application submitted on portal.

In case of any dispute, the decision as approved by the Executive Committee / General Council of AICTE shall be final and binding.
