15. Multidisciplinary / interdisciplinary

The core focus of NEP 2020 in higher education is to produce highquality, thoughtful, well-rounded and creative individuals. It can be accomplished by providing an environment for the holistic development of individuals where the skill set can be identified and nurtured by adding human and social values. In order to develop the all-around capacities of the students - intellectual, aesthetic, social, physical, emotional and moral in an integrated manner, our college is preparing to include multidisciplinary subjects. The aim is to make the students equipped with different skills through various collaborations with institutions like research institutions, Ed-techs, consultancy firms and organisations offering skill based training. As the College is preparing to have more multi-disciplinary subjects, the programme learning outcomes along with course outcomes that define the specific knowledge, skills, attitudes and values that are to be acquired by the learner would be identified and would ensure that each programme achieves its goal. The pedagogical approach of the institution would be student -centric, inquirybased, reflective, collaborative and integrative. Summative and Formative assessments and assignments will be used to evaluate the student's learning outcome. The vision of the college is to promote Value-Based Quality Education; hence the college takes efforts to inculcate positivity among the learners through its Value Lab. The value lab conducts Gandhi Exam and other such activities, as well as it also celebrates National festivals like Independence Day and Republic Day. By organising various programmes and celebrations on special days such as International Yoga Day, Teachers' Day, Guru Purnima, Environment Day, and many more helps in imbibing the good qualities and values among students. Mentoring students is also one of the practices of the institution, to enable students to explore future employment pathways after graduation and help them get the most out of their studies. The college is also preparing itself to offer various online courses in the future via various digital platforms. Various online tools are used by the faculties as teaching and learning aids. Group collaboration and interaction, assignments as well as continuous internal assessments are some of the institutional efforts towards blended learning. The College also makes an effort to understand that the pursuit of knowledge is a life-long activity and will make efforts to encourage students to

develop a positive attitude and other qualities which will help them to be successful in life. So, as a whole, Vivekanand Education Society's College of Arts, Science and Commerce is taking care in every step of academic activity to incorporate elements that help to accomplish the requirements of NEP 2020 on higher education, in addition to supporting gross enrolment ratio by providing financial assistance and scholarships. For planning of multiple entry and exit options with relevant certifications, deliberations have started at administrative level. To promote higher level academic/research experience relevant to solve societal problems, some of the existing PG courses will be considered for 4 year honors degree courses.

16.Academic bank of credits (ABC):

The college plans to send a few faculty members to attend ABC workshop to understand the modalities of this process.

VESASC provides opportunities for online as well as digital learning, to promote self learning, productive contribution to the society, preparing the students for more meaningful and satisfying lives and work roles, enabling economic independence. Students are encouraged to enrol and successfully complete courses through online platforms such as Swayam, Coursera etc. to enrich their learning experience. This addresses the different learning needs of students and the difference in the pace of learning. The institution has MoU with the Uni Italian Institution for collaborative ventures and it is looking forward towards internationalisation of education and joint degrees between Indian and other foreign institutions.

Teachers are free to plan teaching-learning in the manner they find the most effective for the students in their classrooms by choosing aspects of innovative pedagogy. To achieve the desired learning outcomes for students and to make teaching learning student centric, training on pedagogical approaches and experential learning was conducted by organising a 3-day internal FDP by IQAC. In order to cater to both the average students as well as advanced learners, students were assessed through Assignments (Designing posters and Podcasts- Media dept), Tests, class presentations by students (Psychology & Sociology dept) and/or Crosswords or Quizzes (BBI dept).

To assess their comprehension in practical ways and their ability to record and interpret the results, students were assigned mini - projects, creation of online Ad films, Documentaries, PR Campaigns and / or preparing E-Journals. The ACP course at VESASC is conducted to instil in the students an interdisciplinary approach for understanding the core concepts, identifying and formatting problems and giving possible solutions. Advanced learners were encouraged to enrol in the Additional Credit Program (ACP) of our College.

Faculty members are actively engaged in designing their curricular and pedagogical approaches within the approved framework through the Learning Management System. The difference in the learning styles of differently-abled students are considered.

Currently, students of first year UG & PG can earn extra credits (through activities such as NSS, NCC, sports, LLE outreach activities, department association activities) as decided by IQAC and approved by Academic Council. Our Institution is going to register under the ABC to permit its learners to avail the benefit of multiple entries and exit during the chosen programme and to enable credit transfer. These initiatives would be highly beneficial to student community and provide flexibility to students to learn as per their ability and needs.

17.Skill development:

Our Institution's objectives are aligned with our Mission - to contribute in creation of an enlightened society through Holistic education. We always strive to ensure that our students, not only become degree holders but also be competent with all the skill sets required. We also strive to make them job ready and develop into socially responsible citizens.

Our Value Lab organizes several talks, poster presentations to senstize the student about social issues. It also constantly emphasizes the importance of being honest, sincere, and hardworking.

Apart from these values, to equip the students with key skills, our Institution runs a flagship program known as "Additional Credit Program". A program run in three modules viz. interdisciplinary learning, development of research based aptitude and social sensitization. The student gets the freedom to choose the learning area, completely different from his or her core subject, gets to work on a research project driven by his or her passion and gets to spend time in NGO's, accentuating the importance of social responsibility. We believe that this program

is able to achieve all our core objectives in shaping the life of a student.

Being very optimistic about our contribution to students academic as well as overall growth, the IQAC committee of our college has planned to implement 12 extra credits to be acquired during the graduation years apart from the regular credits and 8 credits for the post graduates. The credit structure involves two types of credits, ie. Co-Curricular Credits (CCC) and Extra-Curricular Credits (ECC). The CCC credits would be earned by the student from various academic activities such as completing courses from Swayam, NPTL and other online platforms, participation in research based activities, workshops, seminars etc. The ECC credits could be acquired through participation in NSS, LLE, Cultural activities, and Sports. This credit structure rightly suits every student and gives the student freedom to choose the learning activity and make academic growth a rigorous but enjoyable process.

Our institution is planning to tie-up with Global Gyan Academy, to enable and empower organizations and professionals to become leaders of the future. This will give our students the advantage of learning 21 st century Skill Sets as a part of Skills and Ability Enhancement Programs.

Our institute is aware of the challenges that the young graduates have to face in industry and corporate world. To work in this direction, we have signed a MoU with Satyam Institute of Tax Accountant for training Commerce students in the programmes like Excel and Tally and giving them an opportunity to carry out the world of work.

Such skill development programs will enhance the employbaility of our students and face the competition in the job market.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The teachers of our college are already using bilingual and multilingual modes of teaching methodology in regular teaching for the better transaction of the curriculum. Futhermore the college will assess the societal needs and the feasilbility of introduction of particular curriculums in other Indian languages in online and offline modes.

To preserve and promote the Sindhi language, the college has a

well-established Sindhi association. Sindhi is one of the oldest languages of the sub-continent, with a rich cultural heritage and vocabulary. The Sindhi language is now on the endangered list and in order to revive the language, Sindhi Circle was formed. The main objectives of Sindhi Circle were to promote the Sindhi language and to motivate the young generation to preserve the Sindhi Language and Sindhi Culture. Sindhi Circle offers Diploma and Advanced Diploma Courses in coordination with the National Council For the Promotion of Sindhi Language (NCPSL). It also organizes Sindhi Cultural programs for staff and students.

The college also has a well established Marath Cultural Club named 'Marathi Vangmay Mandal'. The club organizes various cultural activities and programs like marathi plays, folk dance, marathi songs etc under the event called 'Rim Jhim' with an aim to promote and preserve rich culture of Marathi tradition. The club also organizes various programs on Marathi Bhasha diwas.

The college organises an annual intra collegiate festival titled 'Talentia' which incorporates unique themes based on blend of traditional Indian and modern cultures. The BAMMC department organises a annual cultural festival named 'RAGA' to celebrate Indian traditions and culture.

The college tied up with Vijnana Bharti (VIBHA) which is a dynamic Science Movement with a Swadeshi Spirit, interlinking traditional and modern sciences on the one hand, and natural and spiritual sciences on the other hand. It is a Swadeshi Movement with modern sciences adapted to national needs. In collaboration with VIBHA, the college organised some talks and competitions for students and faculty as a part of the celebrations of Azadi ka Amrut Mahotsav.

Apart from the above, the college encourages staff and students to participate and compete on various platforms to showcase their talents in Indian arts and culture. For example Youth festival organised by University of Mumbai and various other inter and intra collegiate competitions.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

We are in a process of modifying curriculum by best utilizing flexibility empowered by the grant of autonomy. Continuous review and change of curriculum are an important facet of the teaching-learning process. In order to make the learner equipped with subject specific skills, higher order thinking relevant to

global/national standards, curriculum is undergoing appropriate changes. To focus on OBE, we are modifying the teaching-learning process: revising syllabus, teaching learning process and assessment to align with the learning outcomes. The initial planning of syllabi started with brainstorming in IQAC which outlined pointers and process to be followed. This further reverberated in departments and board of studies discussions. Thus outcome based syllabi are structured and expected outcomes of various programs are chalked out.

The program outcomes have been designed using appropriate graduate attributes, in realizing institutional vision and mission, eg. disciplinary knowledge, problem solving abilities, analytical reasoning, critical thinking, cooperation/ team work. Based on such graduate attributes, higher order skills and subject independent competence, the curriculum is planned. Thereafter, Program Specific Outcomes (PSO) have been planned as per the specific program comprising various concepts of Bloom's taxonomy such as Understand, Establish, Analyse, Demonstrate, Design, Synthesize etc. Furthermore, each course in syllabus and Course Learning Outcomes (CLO) are planned based on each module in a course and also in conformity with program outcomes i.e. mapping between them. In all this planning we pondered on different facets namely, syllabi, effective ways of its delivery with students and assessing the effectiveness of the process.

In this context, flexibility of the system is utilized by all departments to structure syllabi to realize expected outcomes and also examination patterns consisting of various modes of internal assessment, pattern of end semester examination. The best practice was the use of innovative ways in internal assessment by every department or in different courses within the same departments: Group discussions, Presentations, debates, mock court, quizzes, case studies, assignments, problem solving etc. Through this, assessment of student learning levels specific to that course or program was the primary goal. For students, these changes will lead to systematic acquisition of knowledge, skills and better linkage between practical skills and syllabi.

By implementation of the outcome-based approach we are getting closer to learner-centric pedagogies and participatory pedagogies. These methods of participatory and innovative methods of teaching are also addressed in BOS meetings. Planning for teaching and subsequent assessment are the key factors when we are in a process to take our autonomy ahead.

20.Distance education/online education:

During the pandemic, education changed dramatically, with the distinctive rise of e-learning, whereby teaching was undertaken remotely and on digital platforms. Teachers and students pivoted from face-to-face engagement to online environments, thus impacting curriculum, pedagogy, and student outcomes across a variety of disciplines. The teaching strategies included pre-recorded videos and self-directed learning in which teachers assigned specific tasks for students to perform independently. Various additional practical measures were used by teachers to enhance student engagement including constant polling; sharing multimedia; use of interactive tools; recordings, videos, screencasting; presentations; and virtual reality experiences. They used a variety of platforms in their online teaching viz Zoom/Skype as video conferencing tools, online collaboration tools like Microsoft Teams and Google classroom.

A 3-day Interactive Internal Faculty Development Programme on online Teaching Learning Methodologies was organized on Google Meet platform with the objective to share teaching learning methods used by the teachers in order to facilitate mutual learning. Several teachers shared the interactive and innovative methods used by them to enliven their lectures and take the monotony out of online learning.

Microbiology Department successfully conducted an inter collegiate activity 'Microbytes' from 19/11/2021 to 19/1/2022 as a means of continuing the teaching learning process even while the college had shut down. The content had been prepared by students with existing online/offline learning resources and curated by the staff. It aims to facilitate peer-to-peer learning through the use of Google classroom through interactive learning and virtual lab experience followed by assessment on the basis of the quizzes and peer graded assignments.

The Computer-Science Department successfully completed a skill development course Web Development using Flask. It involved learning about git, Python, MySql, flask and web technologies.

One of the focus areas of NEP 2020 in higher education is to provide opportunities for online as well as Digital learning. NEP aims to promote self learning, personal enlightenment, productive contribution to society, more meaningful and satisfying lives and

work roles and enabling economic independence.

In order to adopt NEP online & digital learning in the next academic year various courses have been proposed to offer blended learning to take learning outside the classroom walls and make resources accessible both online and offline. Some of the blended courses are :-

- Economics and Psychology courses help participants think creatively and critically about public policy issues by providing an understanding of behavioural and experimental economics.
- MS-Excel in Statistical Analysis course aims at providing basic working knowledge for using MS-Excel for data analysis in the process of analyzing data using techniques like regression analysis, testing of hypothesis, creating pivot tables, etc.
- Pharmaceutical Microbiology course helps to bridge the academia-industry gap elucidating the concepts of Qualitycontrol, regulations and audit procedures carried out in the industry
- Course on Online Tools and Techniques for Research has been designed to increase the awareness about availability and identification of authentic online resources and to understand channels for scholarly academic writing.

Overall, we are well adept and equipped to provide valuable skills through the blended learning curriculum.

- 2.2.1 The institution assesses students' learning levels and organises special programmes for both slow and advanced learners.
 - To cater to both average as well as advanced learners, assessment through Assignments (Designing posters and Podcasts- Media dept), Tests (Arts & Commerce & Science), class presentations (Psychology & Sociology dept) and/or Crosswords or Quizzes (BBI dept).
 - To assess their comprehension in practical ways and their ability to record and interpret the results, students were assigned mini - projects, creation of online Ad films, Documentaries, PR Campaigns and / or preparing E-Journals.
 - Advanced learners were encouraged to enroll in the Additional Credit Program (ACP) of our College, organize a Software Development Competition (CS dept) and/or participate in research competitions such as, 'Avishkar' conducted by UoM, Anveshan student Research convention and Nusantara Research Project. Short term courses on Swayam and other MOOC platforms were also encouraged.
 - Advanced learners of the Chemistry Department were directed to prepare themselves for competitive exams like IIT, JAM, ICT, etc. The Microbiology Department conducted an online intercollegiate Certificate Course called Microbytes.
 - For slow learners, few detmentpars(Economics, Microbiology, Accountancy) conducted online remedial classes and posted lecture recordings in Google classrooms, used slow paced assessment via 'Pear Deck' and encouraged collaborative learning using groups. Online tools such as the Pen-tablet were used to simplify and illustrate lectures for them.

2.3 - Teaching- Learning Process

2.3.1 - Student-centric methods such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences:

This year teaching learning methodologies went back to the offline mode. The innovations made for online teaching were assimilated along with offline techniques. Classroom interaction in the form of debates, brainstorming sessions, movie screenings and recaps were used by departments of humanities and sciences alike. The methods that involved use of dual coding through audio visual means, such as PPTs, online quizzes through platforms like Google Classroom, Financial Bingo, Pear Deckand simulations made class interactions lively and improved retentive capabilities of students.

Experiential learning was encouraged through roleplays (Psychology dept), live market sessions on equity market subjects (BFM), workshops (MA), along with the curriculum dictated practicals. Auditing documents and financial statements of companies (BAF), portfolio construction (BFM), exposure to case studies and problem solving sessions helped equipping students with hands-on experience in their subjects.

Internships and field projects were organized in practice oriented subjects like Psychology. Digital Marketing related practical assignments on platforms like LinkedIn, Facebook, Instagram & Pinterest, were used by BAMMC students. BSc (IT)

students were introduced to Figma - UI/UX Software allowing them to create their own prototype of software, Webinars on relevant topics were organized by various departments (BBI, BFM) for clarity of subject matter from experts.

I.T. department has two and CS dept. has one computer lab respectively. Psychology department haslab with equipment and test materials.BAMMC department has Media Lab andLanguage Lab. Central Instrumentation Facility has research instruments like HPLC, FTIR, GC, Sonicator and UV-Vis spectrophotometer. Common computer facility is available in the library and in three common computer laboratories for students and also in some departments.College Library is spread over 6400 sq.ft. with collection of more than 62,000 books, e-books, standard reference sources, video cassettes and CD ROM's. We have a total of 402 computers all with internet connections. In AY 2021-22, a total of54 computers were newly added. Some of the old computers were also scrapped. Out of 402 computers, 267 computers are accessible to students. Students and staff have access to wifi facilities of 400 MBPS bandwidth via 20 Access Points and 9 routers. We upgraded our bandwidth to 500 Mbps in January 2022. Each classroom is equipped with an LCD and mic system. We regularly monitor and maintain all this equipment. The College is subjected to internal and external financial audits on a regular basis. VES Management believes in continuous monitoring of the financial aspects of the college. An internal auditor appointed by VES conducted an Internal Audit. The internal and external audits were conducted as per Standards on Auditing (SAs) issued by ICAI. For Aided courses, other audits (Joint Director Assessment, Accounts Office Audit, Accountant General Audit) are also being conducted in a span of 5 to 10 years. These are regulated by the Government of Maharashtra.

For monitoring of statutory compliances (Payment of TDS, GST, PF, PT, and knowledge of Bank reconciliation, Fees collected, cash deposited, bank balance etc.) The internal audit report on completion of the audit was given by the Auditor on 19th September, 2022.

Flash reports are submitted to the trust office by the 7th of every month due to this mechanism the errors are minimized and no audit objections arise .

6.4.3 - Institutional strategies for mobilisation of funds and the optimal utilisation of resources

The major sources of funds include: Salary grants for aided sections from government, Students fees, Interest on corpus, Management contribution, research grants, Government funding agencies, sponsorship, alumni donors.

Before the beginning of the financial year, budgets are solicited from every Department including the Library. Budget for recurring expenses such as salary, electricity, AMC, internet services, IT hardware, stationary, exam related expenses etc. and non-recurring purchases of computers, furniture and other developmental expenses etc. are prepared by the office. This budget is presented to the Management Governing council for approval. Budget estimates, Income Expenditure and audited statements are also presented in the College Development Committee (CDC) meetings for approval. For any purchase/services, sealed quotations are invited from multiple supplier/vendor/service provider. The quotations are scrutinized by purchase committee for parameters like specifications, quality, pricing etc. Comparative charts are prepared before recommendations / final decisions are made.

The available physical infrastructure is optimally utilized by conducting lectures/practicals in shifts. The classroom, auditorium AV room, college ground and VES Sports ground are available with prior bookings for conduct of remedial classe, co-curricular and extra-curricular activities.

Execution: The webinar was hosted through "Streamyard" and was streamed live on Youtube. On 31st July 2021, a bird's eye view of the VESASC was projected by screening videos on NSS, research, infrastructure, Talentia, Sports. innovative teaching, learning and evaluation methods adopted in online mode and the process of admission was also explained lucidly.

Outcome: The FY Admission 2021 webinar had 479 registrations and had received 1.9k views by 10th August 2021. The Webinar obviously helped in reaching out to a number of meritorious potential students and facilitated their admission process.

Examples of IQAC initiated reviews/ implementation this year to ensure that quality in conduct of teaching learning are:

- 1. Additional Credits Allocation System: The Academic council had recommended that the college should offer 12 additional credits.IQAC Guidelines for Additional Credits Acquisition were prepared. The IQAC members deliberated at great length on the distribution of these 12 credits into Co-Curricular Credits (CCC) and Extra-Curricular Credits (ECC). The IQAC encouraged the staff to draw up 20 new Certificate Courses for facilitating the earning of these credits. The various College Committees were also geared up to meet the challenge of maintaining the ECC.
- 2. Continuous Internal Assessment (CIA): The IQAC advised use of a variety of evaluation techniques for the CIA. Various methods for internal assessment like Project work, Group discussions, Presentations, Internships, Field projects, Small Surveys, and submission of activities on Google Classrooms were adopted. At least 2 different methods of CIA are to be used.
- 3. Staff Development Programme on Online T-L Practices used in 2020-21.
- 4. Academic and Committee Audit Report for 2020-21 was submitted for records and review to IQAC by August 2021. The new format introduced in previous year ensured coverage of both online and offline activities.

Wet waste from the College Canteen and campus is collected and added in these pits. The compost generated from the same is used for gardening purposes. E-waste is minimized by making optimum use of computer hardware, with increasing computational needs, newer versions of computers are required in some labs whereas other labs do not have such requirement. Therefore, as a policy, after procuring new computers in engineering college, under the aegis of VES management, that has more demand for intensive computations, old computers are transferred to VESASC institute. These are put in labs where it can be used for extended time. Furthermore, e-waste is segregated and sent for scientific disposal.
