3. Detailed syllabus for F.Y.B.Com (Finance) (based on the above course structure) as per NEP was

presented by Ms. Kiran Ghosh. BOS members found the detailed syllabus to be appropriate as per NEP requirements.

Mr. Fenil Dedhia suggested that the concept of Depositories should be added in the subject of Introduction to Finance & Financial Systems and Dr.Sangeeta Kanojia suggested to include Partnership Final Accounts instead of Final Accounts in the subject of Financial Accounting. All the BOS members agreed upon both these suggestions.
5. With the permission of the Chair, under A.O.B. following matters were brought under discussion:
 - a. It was discussed that detailed syllabus for Open Electives shall be prepared based on subject selection by students and it was accepted by the BOS members.
 - b. It was also discussed that the scheme of evaluation for Internal and External Examinations will be as per the guidelines for Evaluation by Government of Maharashtra and University of Mumbai in view of implementation of NEP 2020 guidelines, as and when it may be released.
