**Agenda Item No. 1: (a)** To scrutinize and approve the proposals of the various Boards of Studies. Syllabus of 17 Undergraduate Departments i.e. (1) Physics (2) Chemistry (3) Microbiology (4) Mathematics (5) Accountancy (6) Commerce (7) Economics (8) Sociology (9) Psychology (10) Management Studies (11) Mass Media and Communication (12) Banking & Insurance (13) Financial Markets (14) Accounting & Finance (15) Computer Science (16) Information Technology (17) Biotechnology along with core subject of Foundation Course and ancillary subject of Business Communication, Communication Skill and Hindi and 4 Post Graduate Department i.e. (1) Chemistry (2) Microbiology (3) Psychology & (4) Accountancy also tabled the Syllabi for the PG Courses viz. M.Sc. (Organic Chemistry) & M.Sc. (Analytical Chemistry), M.Sc. (Microbiology), M.A. (Psychology) and M.Com. (Accountancy).

## **(b) Examination Pattern Proposed for the above Courses:**

College Examination Cell Controller Dr. Santhini Nair proposed the following details

- Adoption of Choice Based Credit System for UG & PG Courses.
- The performance of each learner will be evaluated in two components.  
For UG programs: (Individual passing)-(75:25)  
Internal Assessment (25% ) & Semester End Examination (75%).
- For PG programs: (Individual passing)-(60:40)  
Internal Assessment (40%) & Semester End Examination (60%).  
Internal exams would include Minimum of two Academic activities (Test/PPT/Project etc.) -BOS decision
- There would be no internal exams for Practical Papers
- **OSM (On Screen Marking) introduced for Evaluation / Moderation / Revaluation of answer books with proper security measures**
- Moderation will be done as per University Norms.
- Revaluation process shall be ONLY for theory papers of all
- examinations and for the applications received within permitted
- time limit.
- Online assessment can be used for Internal Assessment (ERP)
- Passing in each individual head -is a minimum of 40% (Independently in External and Internal). • However, Overall Grades would be given by combining marks of External and Internal exams marks in aggregate for each course .
- ATKT as per University Norms

- **Revised Scheme of Evaluation** under Choice Based Credit and Grading System (CBCS) for UG programs is applicable from the A.Y. 2022-2023 progressively. • At the end of every semester, a student will be awarded a grade based on his/her performance in examination and/or assignments in every course registered by him/her. The college will adopt 10-point as recommended by UGC and adopted by MU.

### Following Ordinances were proposed

O.299 : Candidate shall be eligible for the award of maximum 10 grace marks, wherever necessary in addition to the mark secured in each head of passing for participation in any one of the activities like Sports, NCC, NSS, DLLE Regulation 8917 : As per R. 8917, a learner who does not appear in some or all the courses on medical grounds or for representing the college/ University in Sports, cultural activities, activities of NSS, NCC or Sports training camps or for any other reason which is considered valid under exceptional circumstances and to the satisfaction of the Principal or Head of the institution is eligible to appear for additional examination.

- Results would be declared **within 45 days** from the date of the exams

### (c) Proposed Additional Credits under Autonomy

Minimum of 6 Additional credits for UG Programme (120+6) and minimum 4 Additional credits for PG Programme (96/100 + 8)

- These Credits could be earned from both Co-Curricular activities credit (CCC) and Extra-curricular activities credit (ECC).
- For UG - Minimum 4 Additional credits out of the total requirement of 6 credits have to be from CCC, while there is no upper limit on the same.
- Minimum of 4 Additional credits for PG Programme (96/100 + 8)
- Minimum 2 credits have to be from CCC, while there is no upper limit on the same.
- Student can earn as many additional credits as they can which will be mentioned in their mark sheets.

College will conduct add-on courses for additional credits and also give credit for MOOC through various platforms like SWAYAM, NPTEL, Coursera etc... after approval of respective departments.

## Suggestions

- Dr. A. Subramanian (Kumar) suggested to include Internships, Field visits for Final Year Students to improve job prospectus.
- Dr. Rajendra Shinde opined that Syllabi have to be presented with proper accounting of no. of lectures and no. of credits per paper.
- Dr. Avinash Kale suggested to include 'Gender Sensitization and Multiculturalism' in the Syllabus of Sociology and include case studies for the same.
- Mr. Balaji Ramadurai suggested that more Project Work be given to the students by co-relating the syllabus to relevant topics and have options to choose courses across faculty.
- Mr. Sunil Gwalani suggested to change the entire one unit on presentation skills and include email etiquettes, concepts of smart board, non-verbal body language, use of graphics/animation in presentation.
- Dr. Kiran Mangaonkar, University Nominee, suggested that it would be ideal to have 12 additional credits in addition to University Credits for UG Courses under CBCS in accordance with New Education Policy 2020, which was accepted by all.

**Resolution 1 (a)** It was resolved that the Syllabi of 17 Undergraduate Departments i.e. (1) Physics (2) Chemistry (3) Microbiology (4) Mathematics (5) Accountancy (6) Commerce (7) Economics (8) Sociology (9) Psychology (10) Management Studies (11) Mass Media and Communication (12) Banking & Insurance (13) Financial Markets (14) Accounting & Finance (15) Computer Science (16) Information Technology (17) Biotechnology along with core subject of Foundation Course and Hindi. 4 Post Graduate Department i.e. (1) Chemistry (2) Microbiology (3) Psychology & (4) Accountancy was scrutinized and unanimously passed.

The Syllabi for ancillary subject of Business Communication and Communication Skill was passed after modifications.

- College will conduct add-on courses for additional credits and also give credit for MOOC through various platforms like SWAYAM, NPTEL, Coursera etc... after approval of respective departments.

**Agenda Item No. 2:** To approve and make regulations regarding the admission of students to different programmes of study in the college keeping in view the policy of the Government.

The Chairperson proposed the increase intake considering the demand for the following courses:

- M.Sc. Microbiology from 10 to 30
- M.Sc. Analytical Chemistry from 10 to 40

The Chairperson shared that the management wants to discontinue courses having intake less than 50% for last five years. These courses include TYB.Sc. (Mathematics), M.Com. (Business Management) and M.A. (PR)

**Resolution No. 2:** It was decided unanimously to continue the admission procedure as guided by the State Government and University of Mumbai from time to time.

Academic Council Members approved the additional intake and discontinuation of courses in principle and suggested to report the same to the parent university.

- The E-Commerce Course should also focus on Entrepreneurship. Emphasis on Marketing and Research Methodology should be enhanced.
- The Academic Council Members suggested to maximize the exposure w.r.t. Industry through Live Projects, Internships and Expert Lectures.
