<b>15.Multidisciplinary / interdisciplinary</b>	

Our college has implemented NEP 2020 from the Academic Year 2023-2024. After several discussions and deliberations, we largely adopted a discipline specific approach in order to transact enriched curricula in most of our Programmes. At the same time the flavour of multi-disciplinary and interdisciplinary approach was reemphasized through the introduction of Major, Minor, and Open Elective (OE), Indian knowledge System and other verticals, allowing students to explore diverse disciplines and develop a broad and versatile skillset. Students can choose a Major as their primary field of study and a Minor in a different field, enabling them to blend disciplines. While majors provide in-depth knowledge and expertise in a chosen subject, Minors allow students to diversify their learning and explore complementary or entirely interdisciplinary fields. Open Electives are courses offered outside the student's core discipline, enabling them to gain insights into other fields. UG students are encouraged to undertake field projects or research that combine concepts from different disciplines. The OE Mela, wherein students set up stalls exhibiting the learning and practical aspects of different Open Elective subjects has become a signature event at VESASC, embodying the college's commitment to the open learning environment as projected under NEP 2020. The flexibility of UG programs under NEP allows students to explore various disciplines in the early stages before committing to a Major or Minor. The optional fourth year provides a research-intensive opportunity, often involving interdisciplinary themes. Students gain critical thinking, problem-solving, and adaptability skills through exposure to varied disciplines.

#### **16.Academic bank of credits (ABC):**

We have implemented NEP 2020 from 2023-2024, We have generated ABC Id's on the Academic bank of Credit Portal on the Ministry of Education, Government of India Portal for all our FY and SY students. Students can earn credits from different institutions or disciplines through ABC, enabling them to take courses in diverse areas and accumulate them towards their degree.

#### **17.Skill development:**

Aligned with the Skill Development Component of NEP 2020, our institution emphasizes holistic education by equipping students with essential 21st-century skills, fostering social responsibility, and enhancing employability. Through our "Additional Credit Program", students gain interdisciplinary knowledge, develop research aptitude, and engage in social sensitization via NGO partnerships. Co-Curricular Credits enable

students to explore online platforms like SWAYAM, NPTEL, and Coursera while participating in research, cultural, and sports activities. We have entered into MoU with some organisations like Satyam Institute of Tax Accountant and Rebelcorp which will help in imparting skill based courses to our students and make them job ready. Under VSC vertical of NEP 2020 all departments have introduced subject specific skill courses as well as general courses to enhance the employability of our graduates.

#### **18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)**

National Education Policy (NEP) 2020 emphasizes the integration of the Indian Knowledge System (IKS) into the education framework to promote cultural heritage, linguistic diversity, and holistic learning. We have implemented NEP 2020 from the academic year 2023-2024. A course on IKS was introduced to all FY students across all programmes. Traditional knowledge systems like Ayurveda, Yoga, Vedic mathematics, ancient Indian science, and philosophies are integrated into various disciplines. Social science curricula now include topics on India's contributions to world knowledge, in areas such as economics, chemistry and astronomy. We are also familiarising students with Platforms like SWAYAM and DIKSHA which offer courses on IKS, including Indian languages, traditional knowledge systems, and cultural heritage. The teachers of our college are already using bilingual and multilingual modes of teaching methodology in regular teaching for the better transaction of the curriculum. The college has a well-established Sindhi association which promotes the teaching learning of the language ( offers Diploma and Advanced Diploma Courses in coordination with the National Council For the Promotion of Sindhi Language (NCPSL) and also promotes the preservation of Sindhi culture via various cultural programmes. The college also has a well established Marathi Cultural Club named 'Marathi Vangmay Mandal'. The club organizes various cultural activities and programs like marathi plays, folk dance, marathi songs etc. with an aim to promote and preserve rich culture of Marathi tradition. The BAMMC department organises a annual cultural festival named 'RAGA' to celebrate Indian traditions and culture. The VES Society organises a cultural extravaganza wherein the staff members from different VES institutes exhibit their cultural diversity in a competition named 'VES Got talent'

#### **19.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

With the implementation of NEP the syllabi of all FY classes has

been revised to align with the learning outcomes in consultation with respective BoS and the Academic Council. Program Specific Outcomes (PSO) have been planned as per the specific program comprising various concepts of Bloom's taxonomy such as Understand, Establish, Analyse, Demonstrate, Design, Synthesize etc. Furthermore, each course in syllabus and Course Learning Outcomes (CLO) are planned based on each module in a course and also in conformity with program outcomes i.e. mapping between them. In this context, flexibility of the system is utilized by all departments to structure syllabi to realize expected outcomes and also examination patterns consisting of various modes of internal assessment, pattern of end semester examination. The best practice was the use of innovative ways in internal assessment by every department or in different courses within the same departments: Group discussions, Presentations, debates, mock court, quizzes, case studies, assignments, problem solving etc. Through this, assessment of student learning levels specific to that course or program was the primary goal. For students, these changes will lead to systematic acquisition of knowledge, skills and better linkage between practical skills and syllabi. By implementation of the outcome-based approach we are getting closer to learner-centric pedagogies and participatory pedagogies.

## 20.Distance education/online education:

With the mplementation of NEP 2020 ,our students got the opportunity to pursue various courses in the online mode. This flexibility became available from the verticals of Co-Curricular credits and Vocational and Skill enhancement courses. Students completed many such courses from portals like SWAYAM /NPTEL, Coursera Udemy among others. Another opportunity for distance or online education opened for the students shifting from from Non NEP to NEP .The Equivalence Committee makes recommendations to fill the gap in syllabus/ curriculum with respect to IKS, bridge courses ,etc. using online /offline mode.

### 1.3 - Curriculum Enrichment

1.3.1 - Institution integrates cross-cutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability, and Human Values into the curriculum

In the academic year 2023-24, the institution integrated cross-cutting issues such as professional ethics, gender, human values, environment, and sustainability across various programs. For instance, B. Com (Financial Markets) incorporates Business Communication and Environmental Science to develop professional skills and awareness of ecological issues. The Microbiology course emphasizes the role of microbes in sustainable development through topics like biofertilizers and waste treatment. Similarly, Chemistry students learn about water analysis, promoting environmental responsibility. Biotechnology focuses on wastewater and hazardous waste management, while Sociology courses explore gender issues and social change. Programs like BAMMC address gender, culture, and media ethics, and BA (Economics) offers Environmental Economics, addressing sustainable development and environmental policy.

The B. ## 2.2 - Catering to Student Diversity

2.2.1 - The institution assesses students' learning levels and organises special programmes for both slow and advanced learners.

The college assesses students' learning levels through continuous internal assessment, classroom interactions, periodic tests, group activities such as quizzes, presentations, etc. Our college has a unique "Student Connect" program in which teachers personally interact with students and understand their learning level.

For slow learners, several departments conduct remedial classes and encourage students to write answers. Departments conduct collaborative learning activities, and innovative methods such as the Buddy Program where final year students are paired with first year students. Revision of modules through gaming activities is yet another creative approach.

The college also takes steps to keep the advanced learners motivated and challenged. An annual "Best Student" award is given to a student who excels in cocurricular as well as extracurricular activities-by the college and some departments. Advanced learners are encouraged to undertake small research projects and publish/ present their work at academic events. A total of 14 projects involving 27 students from various departments were selected at zonal level for Aavishkar Research Convention. Some departments coach their students to participate in aptitude/entrance exams while others train their students to participate in national level subject-based competitions.

Guest lectures by eminent scientists and alumni are conducted regularly to inspire and motivate the students.

## 2.3 - Teaching- Learning Process

2.3.1 - Student-centric methods such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences:

The different activities held in various departments cover a wide array of teaching-learning modalities including experiential, participative and problem-solving methodologies across disciplines including finance, business administration, microbiology, psychology and banking & insurance. The activities were positioned to value the students' understanding while employing various student-centric techniques including quizzes, debates, inductions, training programs and experiential exercises.

Student-centred learning experiences included activities such as "Trade with Technical (Candlestick) Charts," by the Financial Markets (FM) Department, and demonstrations of cognitive methods like the "Dichotic Listening Task" by the Psychology Department. Exhibitions by Physics, Chemistry, Maths, Microbiology and Biotechnology departments gave students opportunities to showcase what they had learnt. Additionally, study tours, conducted by nearly all departments, provided students with practical, real-world insights into their respective subjects.

Participative learning is achieved through Team-building and student enrichment activities by departments and committees e.g. Peer learning, role-playing, relaxation therapies, and brainstorming by departments of Psychology, Microbiology and

Commerce, debating activities by the FM Department and 'Tol Mol Ke Bol' by Banking & Insurance Department, made learning fun filled and effective while involving students in groups, leveraging their problem-solving and presentation skills.

Teachers are increasingly incorporating Information and Communication Technology (ICT) tools into their teaching practices to enhance student engagement, facilitate learning, and improve educational outcomes. Tools such as PowerPoint, Prezi, and video content are employed to design visually appealing and interactive lessons. Students are provided access to a wide array of digital texts and research materials, fostering independent learning and critical thinking.

The use of multimedia resources, including videos, podcasts, and AI-enabled interactive simulations, helps simplify complex concepts while accommodating diverse learning styles. Virtual platforms are utilized for real-time demonstrations, and screenings of short films, advertisements, and documentaries further enrich the learning experience.

Applications like Google Docs facilitate collaboration on group projects, while online quizzes and gaming activities promote active participation. Experiential and participative learning approaches are encouraged, with students undertaking surveys and engaging directly with members of society, such as house helps, laborers, shopkeepers, hawkers, beggars, auto drivers, and tailors.

Students conducted interviews, completed Google Form surveys, recorded videos, and geo-tagged photos, presenting their findings, observations, and recommendations through detailed presentations. These initiatives provided practical exposure and honed their analytical and communication skills.

2.5.3 - IT integration and reforms in the examination procedures and processes including Continuous Internal Assessment (CIA) have brought in considerable improvement in the Examination Management System (EMS) of the Institution

The college implemented the National Education Policy (NEP) for first-year students, allocating 60% weightage to external exams with 40% weightage assigned to internal evaluation. All examinations were conducted in accordance with the guidelines and approval of the academic council.

Automation of Examination Processes: The examination system has fully IT integrated through the use of an ERP system, automating

mark entry, grade calculations, percentage computations, result preparation, and analysis. IT integration streamlined processes such as question paper submission. The Examination Management System is used to allocate supervision duties. Senior faculty members of the college scrutinized question papers and provided feedback to improve question-setting methods and question paper templates were designed to minimize paper usage during printing. Various departments used Google Classroom for internal evaluations, the microbiology department instructed students to submit their journal entries on Google Classroom, which were reviewed, corrected, and returned by the teachers. PLAT (Progressive Learning Ability Test) was conducted to check the attainment level of TY students using office software.

**Inclusion of Diverse Evaluation Components:** OE subjects provide students with practical experience, such as the Virtual Trading initiative in FYBA OE and Photography in FYBSc Science OE, offering a comprehensive assessment of students' capabilities through their chosen subjects, thus making it more student-centric.

**Continuous Internal Assessment(CIA)** encourages regular tests to be taken. This approach reduces exam-related stress and it also promotes the idea of learning at all times.

clearly defined and aligned with the institution's educational goals. Students are informed about the evaluation pattern. Project, presentations, seminars, field report, lab work, which have a structured framework for evaluation.

**Active Learning Assessments:** We incorporate diverse evaluation methods alongside term-end examinations to enhance our academic programs. Open-book tests in Accountancy, regular quizzes in Economics and Science, debates and presentations in Psychology, Science and Sociology, role plays and Business Management and Finance, simulations in physics, interactive games, group projects, surveys, and case studies in Microbiology and other disciplines, video making, podcasting, and poster presentations in E-Commerce and IT foster creativity, make learning engaging and enjoyable.

#### Result analysis:

In undergraduate programs, the pass rate for third-year students in aided programs increased from 76.25% to 87.67%, while second- and first-year students had pass percentages of 82% and 85%, respectively. In self-financing programs, the pass rate exceeded 90% for all three years. In postgraduate programs, the overall pass percentage was 95.2%, demonstrating the successful achievement of course objectives.

## INFRASTRUCTURE AND LEARNING RESOURCES

### 4.1 - Physical Facilities

4.1.1 - The Institution has adequate infrastructure and physical facilities for teaching-learning, viz., classrooms, laboratories, computing equipments, etc.

The college is committed to fostering interactive learning environments and has 38 well-equipped and spacious classrooms. All the classrooms are ICT-enabled and equipped with LCD Projectors, LAN and WiFi access points, and audio systems. This ensures an engaging pedagogical experience.

The conference room with the interactive panel is a new addition and is used for research presentations by research scholars as well as for the BOS and other meetings.

The college places a strong emphasis on practical learning which is evident through our well-equipped laboratories, each designed to support the specific needs of different disciplines. We have dedicated labs for Physics, Chemistry, Microbiology, Biotechnology, Mathematics, Information Technology, Computer Science, Psychology, and BAMMC courses. In addition, the computer labs on the fourth floor are shared by Data Science and Data Analytics, E-Commerce, and other departments. These facilities provide students with the hands-on experience to complement their academic coursework.

The Central Instrumentation Facility has advanced research instruments, including an HPLC system, FTIR, Gas Chromatography, Fermenter, Sonicator, and UV-Vis spectrophotometer.

The college has a dedicated computer center for On-Screen Marking-based examinations.

Our 6250 sq. ft. library offers a spacious and well-designed environment to browse, study, and engage with a rich collection of learning resources.

Every classroom is equipped with an LCD projector, CPU and an audio system. Institutional email IDs are provided to staff, students, departments, and committees. We also use Google Suite as our Learning Management System, enabling online assignments, sharing study materials, and resource management through Google Classroom.

To enhance security, the management has implemented a centralized firewall with standard policies to block access to restricted websites. Additionally, the campus is monitored with CCTV surveillance for improved safety.

The college operates in two shifts, morning and afternoon, ensuring optimal utilization of all infrastructure facilities.

A booking system is in place to ensure proper allocation of Auditorium, Audio-Visual room, and Conference room.

Library: Staff and students can borrow books, magazines, periodicals, and other materials following established rules. The library also conducts regular stock-checking activities.

Laboratories are overseen by the Laboratory Assistant under the guidance of the HOD/Coordinator, maintaining an inventory of equipment and consumables. Annual stock checks and withdrawal or disposal activities are carried out as part of the process.

Student monitors are assigned on each floor to report maintenance issues to Mr. Sachin Tumbare or Mr.

Balasubramaniam. The office logs complaints related to furniture, plumbing, and electrical work, with in-house staff handling most concerns. External experts are consulted when needed. Annual Maintenance Contracts cover firefighting systems, ACs, lifts, pest control, and water purifiers.

The IT support staff performs preventive maintenance on IT equipment every six months.

VES College ground is available to students for sporting activities. Sports teachers, under the guidance of the Sports In-Charge, conduct inventory checks of sports equipment and manage the indoor games facility.

**Introduction:** Our college has adopted the transformative NEP 2020 framework, initiating holistic, multidisciplinary, and inclusive education programs.

**Problem Statement:** As an autonomous college, implementing NEP-2020 required redefining the curriculum to foster multidisciplinary and skill-based education.

**Process:** The College addressed these challenges by adopting the following strategies aligned with structural guidelines from the UGC and Government of Maharashtra.

- Academic Coordinators facilitated the implementation of NEP 2020.
- Faculty members were encouraged to attend workshops on NEP 2020 implementation.
- The Open Elective (OE) baskets introduced by the college in undergraduate courses have offered students multidisciplinary exposure. Innovative practices like sharing the learnings in an 'OE Mela' aided in appropriate selection of the same by the juniors.
- IQAC through brainstorming implemented the CC cards and On-the-Job Training (OJT) with corresponding guidelines.

- The Equivalence Committee and Sunday School facilitated the transition of Non-NEP students to NEP through bridge courses and curriculum updates.

**Outcome:** The effective implementation of NEP 2020 by our concerted efforts, boosted admissions, enhanced collaborations and student engagement, improved academic performance.

The college has prepared a Perspective Plan (2021- 26) based on SWOC analysis ,NAAC and autonomy reports, providing a strategic roadmap for academic excellence research & innovation. The deployment of the Perspective Plan in 2023-24 ensured that the institution continued to progress towards its vision and mission, achieving measurable outcomes.

Aligned with NEP 2020, institution implemented a structured credit distribution system and revamped assessment modalities across all courses. Incubation Cell promoted entrepreneurship through guest lectures and pitching competitions.

Holistic development was emphasized through extracurricular activities and sustainable practices led by the Green Club, earning the institution recognition from the Energy Swaraj Foundation for contributions to global sustainability.

## 6.3 - Faculty Empowerment Strategies

6.3.1 - The institution has effective welfare measures for teaching and non-teaching staff and avenues for their career development/ progression

The College offers a diverse range of welfare measures:

#### **6.4 - Financial Management and Resource Mobilization**

##### **6.4.1 - Institution conducts internal and external financial audits regularly**

The college undergoes regular internal and external financial audits to ensure transparency and accountability in its financial operations. The VES Management conducts regular meetings with accountants and instructs them with the updation of policies and practices to be followed from time to time. Internal and External Auditors are appointed to conduct thorough audits in compliance with the Standards on Auditing (SAs) issued by the ICAI.

For aided courses, additional audits are conducted periodically by government authorities, including the Joint Director Assessment, Accounts Office Audit, and Accountant General Audit, typically within a 5 to 10-year cycle, as mandated by the Government of Maharashtra.

To ensure statutory compliance in areas such as TDS, GST, PF, PT payments, and to maintain proficiency in bank reconciliation, fee collection, cash deposits, and bank balances, internal audit

reports are prepared and submitted by the auditor. Additionally, monthly flash reports are submitted to the trust office by the 7th of each month, which has helped minimize errors and ensure the absence of audit objections.

This robust system of internal and external financial audits has significantly enhanced the confidence of all stakeholders in the financial statements presented by the management.

#### 6.4.3 - Institutional strategies for mobilisation of funds and the optimal utilisation of resources

The institution has a well-structured policy to mobilize funds and ensure optimal resource utilization. Key funding sources include government salary grants for aided sections, student fees, corpus interest, management contributions, research grants, government agency support, sponsorships and alumni donations. Before the start of each financial year, all departments submit budget proposals. The administration compiles budgets for recurring expenses, salaries, utilities, maintenance, internet, and examinations and non-recurring investments IT, equipment and furniture. These budgets are presented to the Management Governing Council for approval and discussed during College Development Committee (CDC) meetings, which review budget estimates, income-expenditure statements, and audited reports. The institution follows a transparent

procurement process by inviting sealed quotations from multiple suppliers. Some common purchases are done at trust level with proper negotiations by the central team. A purchase committee evaluates these quotations based on specifications, quality, and cost, conducting a comparative analysis to finalize decisions. The physical infrastructure is utilized efficiently, with scheduled shifts for lectures and practicals. Classrooms, AV rooms, and sports grounds are allocated for remedial, co-curricular, and extra-curricular activities through a booking system. The institution applied for a grant under the PM Usha in September 2023 and received it in March 2024.

Academic Coordinators played a pivotal role in fostering participative and decentralized decision-making, ensuring smooth implementation of academic and administrative programs aligned with NEP 2020 guidelines. An Equivalence Committee was formed. Feedback was collected on curriculum and teaching. Academic Audits were conducted and Student Satisfaction Surveys were administered. Student Connect activities were also promoted. Measures like academic diaries, lecture plans, and compensation lectures and the introduction of a timetable maker further streamlined processes. The institution continued efforts to automate admission and examination processes, including online fee payment, online unit tests (where needed) and result processing, to improve efficiency and transparency.

The Academic and Committee Audit Report for 2023-24 was finalized and submitted to the IQAC by June 2024 for review and records. To promote transparency, the IQAC shared this data with

all staff in view-only mode, ensuring easy access to information.

Decisions and modifications arising from Board of Studies (BOS) meetings and Academic Council deliberations were instrumental in aligning policies and programs with institutional goals and stakeholder needs, ensuring continuous improvement in academic and administrative coordination.

This approach enhanced institutional accountability, improved curriculum delivery, and strengthened stakeholder engagement. Students benefited from personalized programs, while staff contributed more effectively to academic development.

The college has demonstrated a strong commitment to sustainability and waste management in alignment with the objectives of the National Swachhta Mission. Several initiatives have been implemented promoting environmentally responsible practices and resource optimization: Aiming at Waste Minimization and Segregation, the college has developed an operational compost pit that processes wet waste from the canteen and campus areas. The compost generated is then repurposed for gardening, fostering a circular economy approach to waste. Chemistry Department's Microanalysis Approach for its practicals, has significantly reduced the use of solvents and minimizes the generation of hazardous chemical waste. This practice ensures that the environmental impact of chemical experiments is kept to a minimum. From the Sustainable Paper Usage point, the college has implemented a policy where examination question papers are submitted online, and printed using A5-sized paper. Mark sheets are printed back to back. Additionally, one-sided blank paper is reused for other printing purposes, reducing overall paper waste. Under E-Waste Management, the college has adopted a policy of minimizing e-waste by optimizing the use of computer hardware. As per the requirement the sister institutes under VES Management share and exchange resources and hence contribute in sustainable approach of utilization.
