Agenda Item 3

To consider the examination reforms proposed by the Examination Committee.

Prof. Pooja Jagasia, Controller of Examinations (COE), presented the proposed examination reforms to the Council. The reforms include revised ATKT (Allowed to Keep Terms) regulations aimed at streamlining academic progression and ensuring clarity in student evaluation. She also informed the Council about the enhancement of question paper standards, developed through a process of anonymous external review to ensure objectivity, academic rigour, and alignment with learning outcomes.

Additionally, it was proposed that ATKT examinations for all semesters be conducted in the month of June each year, thereby providing timely academic clearance, and facilitating smooth progression of students.

Resolution No. 3:

The Council, after due consideration, approved the revised ATKT rules, enhanced question paper standards through anonymous external review, and the conduct of ATKT examinations for all semesters in June, effective from the academic year 2025–2026, as recommended by the Examination Committee.

Agenda Item 4

To inform the members about academic activities conducted under the PM-USHA Grant.

Dr Aarohi In-charge of Soft Components of PM-USHA grant updated the members about the successful conduct of various academic activities under the soft component of the PM-USHA Grant. She also projected the activities that were planned for the next term by the various departments.

Agenda Item 5

To consider the proposal for the introduction of the Fourth Year UG (Honours) Programmes.

Prin. Dr. Anita Kanwar informed the Council about the Government Resolution (মানল লিগ্র ক্লমাক: তুল্ইণা-2022/ম.ক্ল.09/লবহা-3/মিকোকা, ম্রালেয়, মুরাই 400 032) dated 20th April 2023, which outlines the implementation of the National Education Policy (NEP) 2020. She highlighted the provisions related to the introduction of the 4th year of undergraduate education leading to an Honours degree, which is to be considered equivalent to the first year of a Master's degree. The Council was also briefed about the eligibility criteria for students opting for the Honours degree, which includes securing a minimum of 75% marks across all semesters.

It was further informed that while the implementation is proposed from the academic year 2026–27, applications for initiating the 4th year Honours programme must be submitted before October 2025. Therefore, the Council was requested to grant in-principle approval to enable academic departments to formally express their interest and submit proposals for launching the programme, in accordance with the prescribed norms and deadlines.

Resolution No. 5:

The Council approved the proposal for introducing the fourth year of undergraduate honours programmes (B.A., B.Sc., B.Com.) as per NEP 2020 guidelines in principle, to be submitted by the respective departments. The Principal was authorized to take decisions on behalf of the Council regarding implementation.

Agenda Item 6

To consider the proposal for additional intake for the B.Sc. (Biotechnology) programme.

Prin. Dr. Anita Kanwar briefed the Council on the increasing demand for the B.Sc. (Biotechnology) programme. She highlighted that the college is undertaking expansion of laboratory infrastructure to meet the anticipated academic requirements and that five full-time qualified faculty members are already in place to deliver the programme effectively.

Considering these developments, the Council was requested to consider the proposal to increase the intake capacity of the B.Sc. (Biotechnology) programme from the existing 36 seats to 50 seats.

Resolution No. 6:

The Council approved the proposal to revise the sanctioned intake of the B.Sc. (Biotechnology) programme from 36 to 50 seats, effective from the academic year 2025–2026.

1. Introduction of English Literature as an Open Elective (OE):

2. Review of BBA and BMS Admissions:

The Principal informed the Council of challenges in BBA and BMS admissions under AICTE specifically, delays in timelines and reluctance to undertake the MAH CET as an entrance, which have affected intake.

The Principal proposed that, if BBA/BMS seats by AICTE allotment process through MAH CET remain unoccupied, the college may be allowed to commence the B.Com (Business Administration) programme, with an intake of 60.
